# Economic Growth Center Director's Report

1987-88

The Economic Growth Center in 1987-88 included seven tenured faculty and five untenured faculty, three affiliated faculty from Yale Departments other than economics, six secretaries and clerical staff and four management and professional staff. There were 12 visitors in residence at the Center for various periods of time, mostly from abroad. A list of visitors and faculty is attached. Three new appointments in the Economics Department may participate in the Center next year: James Heckman, Ariel Pakes, and Joosung Jim. Our offer of a professorship in Latin American Economics to Jere Behrman at University of Pennsylvania was unfortunately rejected, leaving us again without leadership in the Latin American area at the Center and in the Economics Department.

The Center's activities are primarily reflected in the publications of the faculty, a list of which is attached. These are summarized in Gustav Ranis' report of last year and are not repeated here. The second Simon Kuznets Memorial Lecture was held on April 6-8, 1988 at which Professor Amartya Sen of Harvard presented three lectures on "Inequality Reexamined."

New projects were funded by the Hewlett Foundation in Population Economics and the Rockefeller Foundation in Research and Training in Gender Differences, Economics of the Family, and Technical Change in Low Income Countries. These grants to T. Paul Schultz will extend predoctoral and postdoctoral training activities in the Center.

Robert Evenson and John Strauss obtained a second multiyear commitment from the Agricultural R&D agency in Brazil to continue the Center's collaborative work with staff in Brazil. Further linkages with the Statistics and Census Bureau in Brazil to undertake research and train staff in micro econometric and demographic analysis is also being discussed.

Koichi Hamada has negotiated support for the Center's program of International Studies on Japan and the World Economy with particular focus on the long term consequences of the Japanese current account surplus and savings behavior. Several Japanese government agencies including MITI, NIRA and Ministry of Finance, as well as private corporations, are exploring means of supporting Hamada's program of research and scholarly exchanges with Japan. Robert Evenson has obtained NSF support to investigate how patent activity can be allocated by industry and analyzed by country of origin to determine the payoff to R&D activity in the world.

## University Policies on Sponsored Research in the Social Sciences

The contraction of USAID and NSF funding of research relevant to economic development has forced the Economic Growth Center to turn to private foundations and foreign agencies for support of research and training expenses. The shortage of funding sources is evident throughout the social sciences. Moreover, Yale provides few encouragements for such research entrepreneurship.

Financially, the Economic Growth Center has for a long time subsidized the Economics Department and the instructional mission of Yale by supporting secretaries for faculty who are predominantly involved in teaching. The Center also administers the highly profitable (i.e. no scholarship given by Yale) IDE Master's degree program, for which it does not receive enough to support the program secretary, TAs and student expenses. Indirect cost recoveries from Center federal grants from NIH, AID and NSF are also twice the level of GA support received by the Center from the University. The Center is not left with the financial capacity to help its faculty in their legitimate research needs, particularly those faculty that struggle to fund some of their research through the University, and absorb the Yale overhead tax of 72%. Not unreasonably, faculty respond by working more off-campus or through the auspices of other agencies that provide more in return for their efforts. This trend reduces the University's fiscal base and reduces the benefits that colleagues and students derive from regular interaction at the Center. I suspect that the record of the last two decades will confirm this pattern throughout the social sciences at Yale.

This is not a criticism of faculty behavior, but a critique of Yale University policy that ignores the deterrent effect of the high tax rate on entrepreneurial activity, particularly when research in the social sciences is not physically dependent on (or greatly encouraged by) Yale facilities. Until the University finds a way to reward faculty for confronting the paperwork of grantsmanship and reducing the Yale overhead tax in the social sciences, research centers in the social sciences will tend to decline.

Even if the availability of government grants improves in the next federal administration, this development is not likely to halt Yale's decline relative to other major universities in terms of on-campus social science research

activity. To reverse the current drift will require that the Yale central administration decide to introduce an improved structure of incentives that recognizes the special character of sponsored research in the social sciences.

A part of the solution to this problem at Yale would be to establish a separate indirect cost recovery pool for the social sciences and humanities which do not depend on laboratories. I have urged for several years that Len Wesolowksi perform the rough calculations to illustrate what such a federally acceptable accounting change would imply for Yale. I would guess that this separation of two cost recovery pools at Yale (similar to the off-campus rate) would increase the rate only a few percent for the natural and medical sciences, while reducing the rate by two-thirds for the social sciences. The added costs of accounting would be minor. The effect on incentives for the social science faculty would be dramatic. Can anyone argue that such a structural change in the allocation of costs would be inequitable?
